- 1. Title of the practice: Capacity and Skill Development for Sustainability

Apart from these, events such as Vanamohatsav, Environmental Day, Yoga Day, Youth Day, Ekta Diwas, Rastriya Basha Diwas, Science Day, Ozone Day and extension programs at adopted villages were conducted.
